## COACH'S CODE OF ETHICS AGREEMENT

### Guthrie Baseball Association

**Prior to participating as a "Coach" in any Guthrie Baseball Association (GBA) related activity or event (activity), I agree to encourage, demand, exemplify and abide by the following:**

1. I will comply with all GBA rules, bylaws, certifications, regulations, and decisions as well as all applicable government rules, regulations and laws.
2. I will encourage and maintain an optimum sports environment for participants, and agree to: **(A)** provide a drug, alcohol, and carcinogenic-free environment; **(B)** provide every opportunity for each Participant to equally engage in any GBA Activity; **(C)** provide proper supervision, training, equipment and first aid, while endeavoring to teach the game in tandem with good sportsmanship and citizenship; **(D)** provide conditioning and training instructions which seeks to optimize safety and health while minimizing injury; **(E)** provide assurances that participants shall not be required, encouraged or influenced, indirectly or otherwise, to engage in any GBA activity while injured, if substantially affected, or if further degeneration is reasonably probable; **(F)** fairly and equally provide positive encouragement to each and every participant regardless of race, color, creed, gender, religious orientation, disability, inability, parental influence or economic status, regardless of my personal beliefs, orientations, or biases; **(G)** provide regular verbal affirmations of the importance of education over sporting Activities, while also giving educational conflicts a higher priority over those activities; **(H)** strive to allow every participant a chance to play more than one defensive position.
3. Regardless of my personal orientation and attitudes toward winning, I will strive to exemplify and instill in my participants that while winning may be an immediate objective, it is secondary to fairness, honesty, integrity, sportsmanship, strength of character and participation. Therefore, I will place the well-being of all participants above any aspirations to win.
4. I will require that my team and all participants, parents, and associated spectators, conduct themselves in a manner consistent with the purpose and aims of GBA, while also leading by example.
5. I will accept any unassigned players placed on my team by the GBA Office.
6. I accept the duty and obligation to report any known illegal or unethical conduct by any Coach, Assistant Coach, Officer, Official, Spectator, Board Member or Director. I also agree to report any other misconduct reasonably calculated to negatively affect any participant or other person or entity associated with GBA.
7. I will insist and encourage that participants play fairly, while demonstrating good sportsmanship among players, officials, fans parents and spectators; to win or lose with dignity; to congratulate any opponent. I agree to treat officials and GBA representatives with respect, and agree to refrain from harassing any coach, player, official or spectator regardless of the situation.
8. I agree to comply with any GBA sanction, ruling or decision and agree to comply with the appeal process set forth in during regular business hours at the GBA offices, and agree to bound thereby. I agree to insure that every participant has completely complied with the registration process including completion of all registration forms, submission of birth certificates and payment of fees.
9. I agree to continually analyze and improve my coaching and teaching methodology and education and understand that failure to execute this Agreement will terminate my coaching privileges with GBA. I hereby certify that I have never been convicted of a misdemeanor or felony involving a minor, nor will I allow anyone with a record of such a conviction on my coaching staff.
10. As Head Coach, I shall have all assistant coaches sign and provide date of birth as listed below.

**When you sign this Agreement, you are certifying that you have read and understood each item and you are voluntarily waiving any claim you may have against GBA or the City of Guthrie in the event you are sanctioned as a result of any violation of the terms of this Agreement. You also agree that the ruling of the Board, following appeal from any sanction recommended or instituted by any Sport Committee, or any ruling by the City of Guthrie Park and Recreation Board, or any other Board operation under the auspices of the City of Guthrie shall be final.**
